## Fletcher Proposes Increase in Environmental Funds

Governor Ernie Fletcher's proposed budget (HB 395) would increase overall spending on Natural Resources and Environmental Protection, much of the increase going to the Kentucky Pride Program.

The Department for Environmental Protection would see a boost from \$77 million this year to \$87.3 million next year, and \$90 million the following year. Those figures includes spending on the Kentucky Pride Program, which would balloon from \$12 million this year to \$25 million next year and to \$30 million the year after. Spending on other Federally funded programs would decrease from \$19.7 million this year to \$16 million next year and \$15.6 million the following year.

Following a decrease in funding this year, the Department for Natural Resources would see a funding increase from \$30.7 million this year to \$38.3 million next year and dipping back to \$37.7 million the following year.

The Environmental Education Council funds would stay flat at \$150,000. Surface Mine Reclamation and Enforcement funding would stay flat as would Abandoned Mine Reclamation.

The Environmental Quality Commission returns to the budget as a separate line item. Last year Governor Patton ordered the Cabinet to fund it out of its budget. Fletcher proposes to reduce it, however, from \$254,000 in 2002 to \$150,000. That is enough for only one staff person and an aid.

Reauthorization of the hazardous waste fees is also contained in Fletcher's budget proposal. These fees paid by hazardous waste producers help pay for cleanup of state superfund sites.

## HB 349: A Real Sinker

HB 349 (Meeks, et al) should have a lead sinker tied to it and be thrown overboard. Poorly conceived and poorly written, this bill threatens human health while unconstitutionally removing an injured party's right of redress in the courts.

The bill seeks to create two categories of properties: "lead safe" and "lead free". Certifying a property as "lead safe" or "lead free" would immunize the owner from liability. HB 349 does not clearly set out, however, what these terms mean and by what mechanism they are to be "certified". The danger to human health is that these labels could mislead the public into believing that a property was safe or free of lead when, in fact, it is neither.

The labels would be misleading because the bill assumes the only threat from lead is paint on the surfaces of a dwelling. There is no consideration for lead in the soil around dwellings or dust arising from the soil that can contaminate the interior of a dwelling.

A property (notice it doesn't say "dwelling") is certified as lead free if it was built after 1978, but this does not ensure that no lead-free paint was used. It is also certified as lead free if the interior surfaces are tested for lead and all exterior chipping and peeling paint is covered over with non-lead paint. Not only is it not "lead free" (the lead paint has not been removed), there is no assurance that chipping and peeling will not continue unabated.

HB 439 does not define who will do the inspection, what qualification the inspectors must have, and what the inspectors are looking for. The language is vague enough that it could be interpreted as self-certification.

A property is certified as "lead safe" if action is taken to reduce the exposure to lead based paint. Again, it does not deal sources of lead other than paint. There is no exposure level at which lead is known to be safe. It causes neurological damage at very low levels. The only way to make it safe is to eliminate exposure.

Certification as "lead free" or "lead safe" can make unsafe property appear safe while it immunizes the owner from liability for lead exposure if the property has been certified "lead free" or "lead safe".

To make the bill even more troubling, if the injured party is made a "qualified offer," the owner is immunized from lawsuit. It doesn't matter if it is a reasonable offer or whether the injured party accepts the offer.

## Billboards Trump Nature?

The billboard industry is at it again. For the umpteenth time, they are trying to obtain the right to chop down trees and shrubs, within 500 ft of the sign, in the public right of way that block the view of their signs. Sen. Ernie Harris is sponsoring SB 114 on the industry's behalf.

## On The Move

Our last Alert highlighted HB 179 exempting local governments from permits to reconstruct stream crossings. The sponsor is no longer expected to push this bill. It appears his concerns about expediting flood damage repairs will be handled administratively, rather than statutorily.

HCR 8, ordering a study of how to complete the Big Sandy Trail looks like it will soon pass in the House. The Big Sandy Trail is a proposed recreational trail from Lexington to Ashland using an abandoned railroad.

HB 281, which recreates the Interagency Farmland Committee, has passed the House. The Committee would report to the Governor all state agency projects converting more than 50 acres of farmland for non-farm use. It requires the committee develop an agricultural impact statement and consider alternatives. Ironically, Governor Patton dismantled the previous Committee in 2002 and the General Assembly repealed the law creating it in 2003. The controversy over the committee started when opponents of The Tri-modal Transpark, an industrial park near Bowling Green, asked the Governor to have the Committee review this project.

## Car Wreck

In the 2003 session, the General Assembly approved legislation ordering the dismantling of Jefferson County's vehicle emission testing program. Kentucky Resources Council, representing Sarah Lynn Cunningham, challenged this law in U.S. District Court.

On January 29 2004, the Judge ruled that the General Assembly overstepped its power and that it was a violation of the Clean Air Act to end the program.

Meanwhile, SJR 3 recently gained Senate approval. SJR 3 declares the Northern Kentucky vehicle emission-testing program unconstitutional, illegal and unenforceable. Stay tuned.
