With seven days left in the 30 day session, any bill not passed by one chamber is most likely dead. If a bill has not already been heard in the second chamber's committee, it has a large uphill battle. Bills recommitted to the Appropriations and Revenue Committee are usually sent there to die.

Ditch SB 175

SB 175 sponsored by Sen Stivers has passed the Senate and moved to the House Natural Resources Environment and would Committee. It allow Environment and Public Protection Cabinet (EPPC) to take over permitting of the filling of streams and wetlands from the Corps of Engineers.

According to Tom FitzGerald of Kentucky Resources Council, this would eliminate the requirement for an environmental impact statement or environmental assessment, and would also eliminate the "public interest review" under which the Corps can deny permits if on balance the public interest is not protected.

It would also mean that EPPC would acquire a new regulatory program under its already constrained budget and limited staff.

The suspected intent is to ease the permitting on mountain top removal mining.

HB 8 Would Increase Road Carnage

A bill to expand the Extended Weight Coal Haul Road System to include sand, gravel, and other "natural resources" was approved by the House and has moved to the Senate Transportation Committee. There is just enough time for HB 8 to squeak out of committee and gain approval by the Senate.

The current limit of 80,000 pounds for no-coal trucks would be increased to 126,000 pounds, in exchange for a fee. Overweight coal trucks are already responsible for numerous deaths and injuries every year because they simply cannot stop or avoid road hazards.

Residents and drivers near sand, gravel and limestone mines will incur the same dangers and quality of life reduction as those near coal mine now do including more deaths and injuries from car-truck collisions.

The Legislature Resource Commission estimates HB 8 would cost \$25 million dollars a year to repair roads and bridges and require \$360 million in bridge replacement projects to upgrade bridges incapable of handling the loads. This would be on top of the costs already incurred by the extended weight coal haul system. The fees would not cover the additional costs.

Advocates have presented this as a fairness issue. In other words, why should coal have a unique advantage? Following this logic, it would be like allowing your kids to drink illegally because your neighbors kids are allowed to drink illegally. KCC believes it was wrong to give coal trucks an exception to the weight limits in the first place.

The 126,000 pound weight limit on coal trucks has been widely ignored with most trucks, by the driver's own admission, running well over the limits. Recent enforcement actions have resulted in agreements by coal companies to come in compliance with the law. It is not unreasonable to expect, however, that other industries would be driven by the same influences to haul over the 126,00 pound limit, too.

Bill Giving Developers Advantage Over Challengers Advances

The Senate has approved SB 157 sponsored by Sen. Stivers, which would require anyone challenging a development proposal or land use change decision before the appeals court to post a \$25,000 to \$100,000 appeal bond. The bill is now in the House Judiciary Committe

This obviously creates a financial barrier to appellate review regardless of the merit of the appeal. "Existing law already grants appellate courts sufficient authority to 'police' bad-faith appeals," claims environmental attorney Tom Fitzgerald.

FitzGerald also says it is unclear whether existing standards for awarding costs for frivolous or bad-faith litigation would remain, or whether a lower standard would be established so that an appellant would be required to pay costs including "delay costs" merely for an unsuccessful appeal.

Such legislation inherently assumes that appellants seeking review of a trial court decision in rezoning case to be frivolous and that there is a need to constrain the right to seek review for all appellants.

Two Ethics Bills Advance

HB 232 introduced by Jim Wayne and Steve Riggs would make planning commissions subject to ethics codes, extend comprehensive plans to project 20 years, requires consultation with specific stake-holder entities for plan adoption. It has advanced to the Senate State and Local Government Committee. The same bill died in this committee last year.

HB 436 sponsored by Rep. Cherry amends Executive Branch Ethics law to include Public Service Commission (PSC) as an "executive agency" and include commission orders as "executive agency decisions." It has also advanced to the Senate State and Local Government Committee. There are currently no ethics laws regarding the PSC.

Privately Public and Secretly Open

The House has passed HB 59 sponsored by Rep Weaver, which would create exemptions to open meeting and open records laws for public utilities such as water, wastewater, sewage and gas. The purported reason is to allow for the protection of vital and potentially hazardous infrastructure against terrorist attack. Fearing it is likely to do more damage to the public's right to know about the presence and handling of and potential exposure to hazardous substances than it is to thwart a terrorist. KCC worked with Jim Wayne to amend the bill to notify the Attorney General and clarify that water quality reports are not included.
